गैंगस्टर संस्कृति को बढ़ावा देने वाले गीतों पर रोक लगाने के लिए सरकार के निर्णय के बाद अब एसटीएफ हरियाणा भी सक्रिय हो गई है। शुक्रवार को यहां एसटीएफ अधिकारियों ने हरियाणवी संगीत कलाकारों के साथ बैठक की। बैठक की अध्यक्षता एसटीएफ के महानिरीक्षक ने की। इस दौरान एसटीएफ के पुलिस अधीक्षक, उप-पुलिस अधीक्षक सहित अन्य पुलिस अधिकारी मौजूद रहे। महानिरीक्षक राजेश कुमार ने कहा कि हरियाणवी संगीत कलाकारों द्वारा कुछ गीतों के माध्यम से अपराध, हथियार संस्कृति, ड्रग का उपयोग तथा कानून विरोधी मानसिकता को बढ़ावा दिया जा रहा है। इसलिए हाल ही में कुछ गीतों को यूट्यूब एवं अन्य सोशल मीडिया प्लेटफॉर्म से हटाया गया है। आईजी ने कलाकारों को कहा कि पुलिस रचनात्मक स्वतंत्रता का सम्मान करती है,

किंतु इसका दुरुपयोग समाज में अपराध, हिंसा या कानून विरोधी प्रवृत्तियों को प्रोत्साहित करने में नहीं होना चाहिए। उन्होंने कहा कि कलाकार जिम्मेदार नागरिक के रूप में कार्य करें और ऐसा कंटेंट न बनाएं जो नकारात्मक प्रभाव डालता है। आईजी ने यह भी स्पष्ट किया कि भविष्य में यदि कोई सामग्री गैंगस्टरवाद, हिंसा या हथियार संस्कृति को बढ़ावा देती पाई गई तो संबंधित कलाकार पर कड़ी कानूनी कार्रवाई की जाएगी। बैठक में मौजूद रहे हरियाणवी संगीत जगत के गायकों एवं गीतकारों व कलाकारों से महानिरीक्षक एसटीएफ ने कहा कि हरियाणवी संस्कृति के गीत बनाएं और गाएं। अपराध की संस्कृति वाले गीतों से परहेज करें। यह हमारी संस्कृति का हिस्सा नहीं है।
